Contract Cleanup: Investing in the Future

The key to contract effectiveness in your business is YOU. Keep in mind:

- Many agreements MUST be in writing to be enforceable. Florida's "Statute of Frauds" may also bar enforcement of unwritten agreements lasting beyond a year.
- A "writing" needn't be entirely "formal," but must sufficiently describe key terms.
- "Form" contracts may include "arbitration," "litigation" and "mediation" provisions. Know the difference between them, including the ability to get information ("discovery"), the cost and time elements of each, and the public/private/future ("precedent") effect of each.
- "Attorneys' fees" clauses in contracts work both ways. If you win, the other

side pays; if you lose, you pay the other side.

Think of that as you make your business decisions.

- An overwhelming number of cases resolve without trial. Prompt dispute resolution can save you money. Maintain documented support. Something as simple as administrative memoranda can upgrade your practices.

Reviewing your contracts with a trusted legal adviser is an investment in the future.
